Problems;

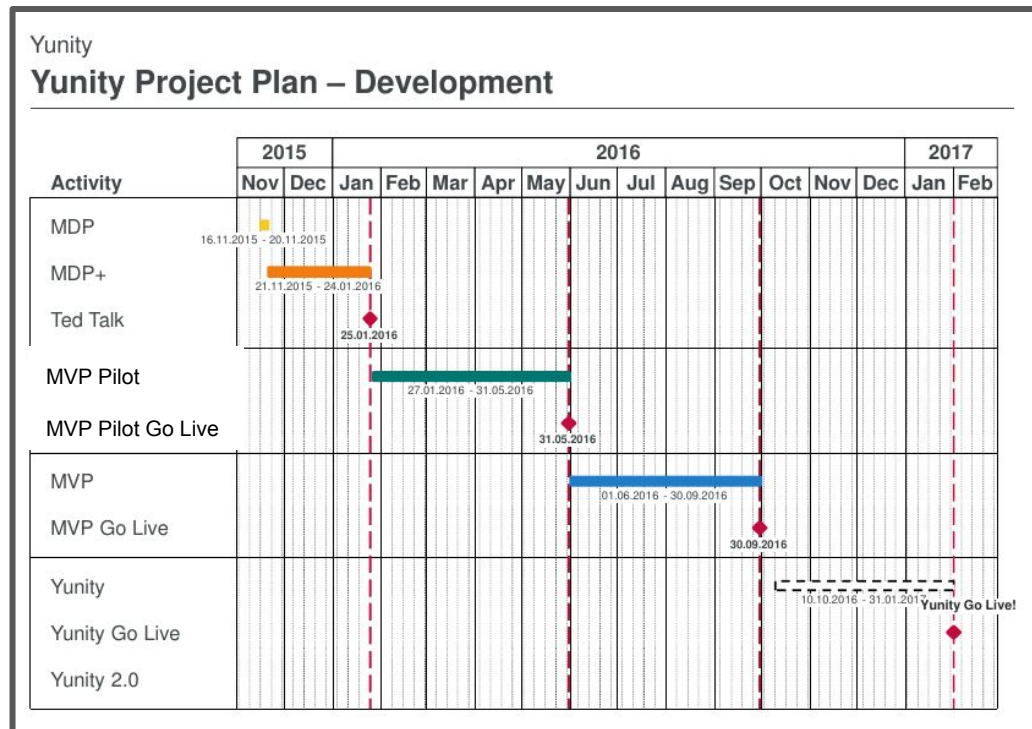
- Confusion about what the agreed meaning of words.

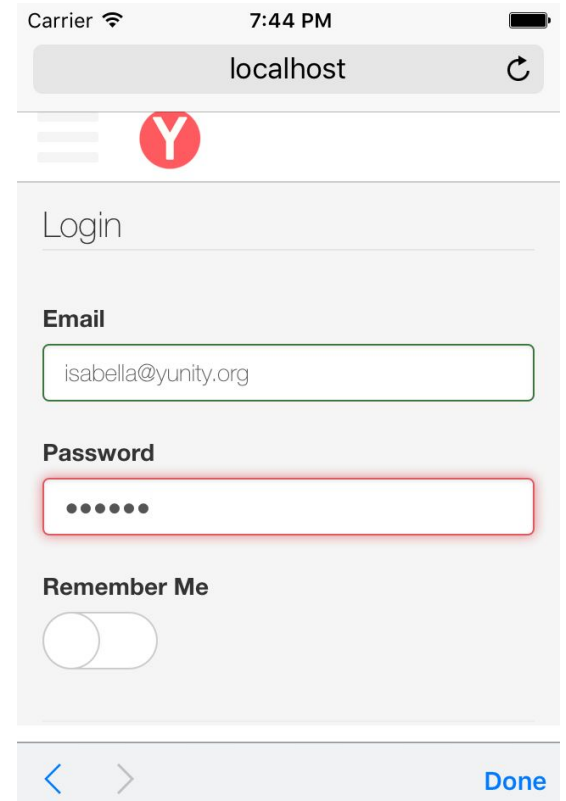
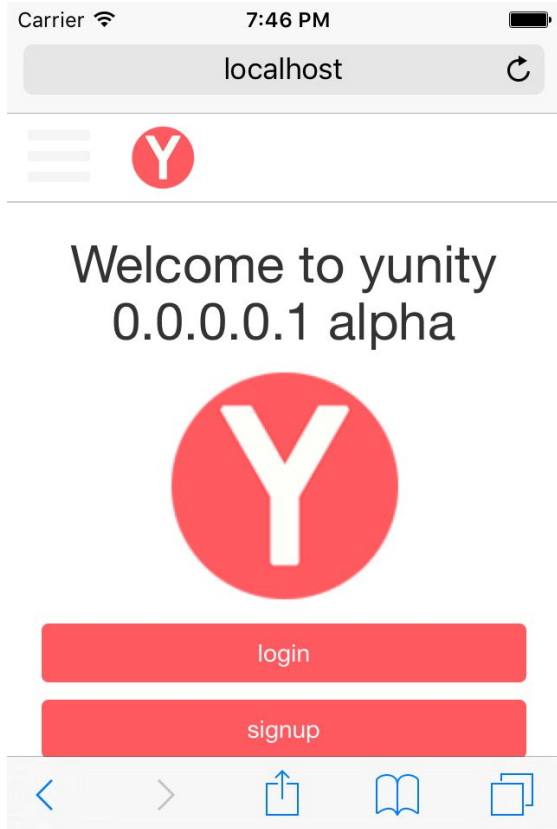
- Conceptualisation of high level product stages in a [product plan](#). Currently just Dev, but method may be useful with other teams (Thanks Kirstin!)



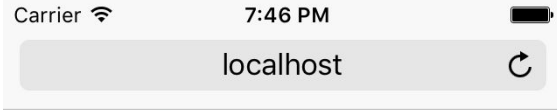

Legal - proposed 'Use of Money' policy

- A lot of philosophy behind the use of money (which would be discussed as a separate page, or in an FAQ).
- We have already used money on behalf of the project and may consider using money again going forward.
- Source of some confusion, as we have no policy on this subject.
- Researched existing foodsharing.de policy and those of other organisations.
- Created a first draft that we believe can answer any question regarding money with 'yes or no':

Legal - proposed 'Use of Money' policy

As little as possible, as much as we need. We consider funding from individuals and organisations in line with our Vision and Mission. We are fully transparent about all funding we use.

Legal - proposal to set up non profit association in Malta

Malta: good image & credibility, removes liability, data protection, in EU (complex legal benefits)

- ❑ Malta is a very important hub for Internet companies (and the biggest in Europe)
- ❑ Malta has a tremendous expertise in managing Internet based activities and is well known for defending its companies
- ❑ association can benefit from the EU e-commerce legislation (limitation of liability of platforms and intermediaries) on a country of origin basis (so Maltese law applies to companies/associations established in Malta)
- ❑ Malta as a member of the EU benefits from all other EU legislation and policy developments (like Digital Economy and the upcoming circular economy strategy) It has also an impact on the relations with other countries around the world (compared to offshore jurisdictions who are on the OECD blacklist and therefor here in Europe their legal status is not recognised so the owners/directors remain totally liable)
- ❑ Malta benefits from its EU status to be considered as transparent and serious (the offshore states are mainly used by the Organised Crime and big multinationals (corporations, entities) with bad reputation and are very expensive)
- ❑ In Malta we can define T&C who are coming under the normal EU legislation and will protect yunity as association

Communication [IT] - selection of wiki software

Problems;

- People can't find what they need in Google Drives easily

- Confusion as to which content is mature and which is draft
 - **No central repository for finalised info**

Solution;

- Set up a wiki!
- Confluence chosen as software solution for [project wiki](#) as it is easy-to-use and fully featured - being set up as we sit/digest
